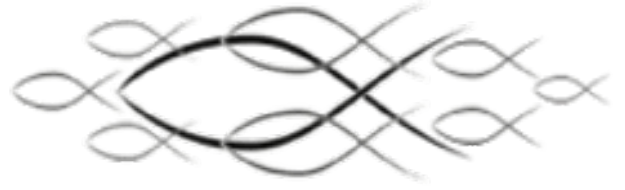


# Living Water Emmaus
